

Terms & Conditions:-

1. Safety measures as per site requirement shall be arranged by the agency and DUSIB shall not be responsible for any mis-happening during demolition.
2. Due care shall be taken by the agency regarding safety of adjoining structures.
3. No T&P shall be issued by the department.
4. No extra charges shall be paid except for the rates quoted.
5. Conditional quotations shall be liable to rejection.
6. Necessary Statutory deductions will be made as per prevailing law.
7. Work shall be completed to the satisfaction of Engineer-in-charge.
8. Debarred / blacklisted agencies shall not be permitted to participate in the NIQ process.
9. The time period for execution of work shall be 30 days i/c removal of debris. The days on which demolition is carried out under police protection shall be counted.
10. Security shall be refunded after successful completion of work and clearance of debries / malba from site.
11. The highest bidder shall deposit the quoted amount along with security deposit within 7 days after acceptance of the quotations.
12. For any disputes the matter shall be referred to SE-II DUSIB for final decision and the same shall be binding upon both the parties.
13. Earnest money shall be deposited in the shape of Demand Draft in favour of EE C-5, DUSIB at the time of purchase of NIQ Document
