The unregistered contractors can also apply provided they also submit the required documents.

The contractor shall submit the following attested documents along with application in the office of the Executive Engineer(E-3).

- i) Copy of TIN Number as issued by DVAT department.
- ii) Copy of valid registration certificate of the department registered with (In case of registered contractors).
- iii) Copy of PAN card issued by income tax department.
- iv) Copy of valid electrical contractor license.

The quotation should reach this office on 24.06.2017 by 4.00 PM which shall be opened on the same day at 4.30 PM in the presence of the participating contractors or their representatives whosoever wish to be present in the office.

The firms who wish to participate in the quotation shall submit their application along with the above documents for issue of prescribed NIQ format on or before 24.06.2017 by 12.00 PM. The prescribed NIQ format, detail description of the item, detailed specifications of the quotations can be obtained from this office on or before 24.06.2017 upto 12.30 PM.
