Deptt. for carrying out manufacturing business, failing which their application is liable to be rejected. The prescribed NIQ format, detail description of the item, detailed specifications of the quotations can be obtained from this office on or before 28-09-2017 upto 3.30 PM. The quotation shall be opened at 4.30 PM on same day in presence of instructed intending bidders.


