## **TERMS & CONDITIONS:**

- 1. The work should be completed within 4 DAYS after the date of receipt of the work order.
- 2. No extra charges shall be paid.
- 3. Percentage rates should be quoted for the work as above & site.
- 4. Conditional quotations shall not be accepted and will be summarily rejected.
- 5. Work should be carry out as per CPWD specifications.
- 6. T&P shall be borne by the agency.
- 7. Drinking water arrangement shall; be made by agency for labor working at site at his own cost.
- For any type of accident, mishaps during execution of work at site shall be sole responsibility of the agency and department shall not be in any case be responsible and liable for such type of accident or mishap.
- 9. Damage to the building etc. shall be made good by the agency at his own cost.
- Time is the essence of the work delay in execution of work shall attract suitable levy of compensation.

- 11. Quotation received after the due date and time will not be considered.
- 12. Payment shall be made by RTGS.
- 13. No out station quotation shall be entertained and accepted.
- 14. The EE(E)/E-I has the right to reject or accept the quotation.
- 15. All disputes shall be within the jurisdiction of Delhi.
- 16. All the scraps and scrupulous material shall be removed from the site.
- 17. All the rejected, un approved material should be removed from the site.
- 18. Sub standard work shall be liable to non release of payment for that article and the agency will be blacklisted, debarred for misleading the department.
- 19. The Watch & Ward, storage of the material shall be the responsibility of the work executing agency.
- 20. The firms shall have to submit the self attested copy of above documents which shall be valid on the date of receipt of application.
- 21. Quotation in sealed cover for items only prescribed NIQ format issued by the office shall only be accepted. Any quotation other than the prescribed NIQ format issued by this office shall not be entertained.
- 22. Intending bidder must see the site condition before submitting the bid. No conditional bid/quotation shall be accepted.
- 23. Schedule of quantity and other terms and conditions of the work be obtain within office hour from the Division before the date and time of opening of quotation.
- 24. The work shall be carried out strictly in accordance with CPWD specifications of Electrical works 2013 as amended upto date and in accordance with Indian Electricity Rules 1956, Indian electricity Act, 1910 as amended upto date.
- 25. All damage done to the building during execution of Electrical work shall be responsibility of the contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-charge (Electrical). Any expenditure incurred by the department in these conditions shall be recovered from the contractor and decision of the Engineer in charge (Electrical) about recovery shall be final.
- 26. The bad workmanship will not be accepted and all the defects shall be rectified by the contractor, if the defects are not rectified, the same shall be got done to the entire satisfaction of Engineer-incharge (Electrical) at the risk and cost of the contractor. The schedule of electrical works is to be coordinated in accordance with the building work.
- 27. All the debris of the electrical works should be removed and the site should be cleared by the contactor immediately after the removing of debris. Similarly any rejected material should be immediately cleared off from the site by the contractor.
- 28. Cement sand etc for this work is to be arranged by the contractor himself and nothing extra will be paid on this account.
- 29. The Contractor or his representative is bound to sign the site order book as and when required by the Engineer-in-charge (Electrical) and to comply with the remarks therein.
- 30. The contractor shall make his own arrangement at his own cost for electrical general tools and plants required for the work including arrangement of water and electricity.
- 31. . Quoted rate should be inclusive of all taxes and duties.
- 32. The entire installation shall be at the risk and responsibility of the contractor until these are tested and handed over to the department
- 33. Notwithstanding the schedule of quantities, all items of inter related works considered necessary to make the installation complete and operative are deemed to be included shall be provided by the contractor at no extra cost.
- 34. The connection, inter connection, earthing and inter earthing shall be done by the contractor wherever required and nothing extra shall be paid on this account.
- 35. Nothing extra shal be paid for inter connections with thimble/wires/tapes strips etc.

- 36. All hardware items such as screws, Thimbles, GI wires etc which are essentially required for completing an item as per specifications will be deemed to be included in the item even when the same have not been specifically mentioned.
- 37. Material to be used in the work shall be ISI marked. The make of material have been indicated in the list of acceptable makes. No other made will be acceptable. The material to be used in the work shall be got approved from the Engineer in charge before its use at site. The Engineer in charge (Electrical) shall reserve the right to instruct the contractor to remove the material which, in his opinion, is not as per specifications.
- 38. The contractor will be required to clear shrub falling on the cable route for which no extra payment will be made.
- 39. The contractor shall deem to have fully acquainted himself with the nature and extent of work and working conditions at site before submitting the tender. The work shall be executed as per preference approved by engineer-in-charge. If the materials, drawing, design etc. are not available due to any conditions, the programme of the contactors shall be modified accordingly and no compensation/damages shall be payable.
- 40. The contractor shall take all precautions by exhibiting necessary caution boards, red flags, red lights and barrier to avoid any accident during execution of work. The Contractor shall be responsible for all damages and accident due to negligence on his part. The contractor shall also provide helmets, safety belts etc. required for labours.
- 41. No payment will be made to the contractor for damages caused by the rains or other natural calamities or riots during execution of work and no claims on this account will be entertained.
- 42. The time of completion shall be essence of the contract and to be strictly adhered to by the contractor.
- 43. The contractor shall make necessary arrangements for medical aid to all his workers including availability of his first aid box all the time at the site of work.
- 44. The department will not be responsible for any kind of about disputes.
