**TERMS AND CONDITIONS**

1. The work shall be carried out as per CPWD specification 2009, Vol-I & II with upto date correction slips.
2. Cement /steel required shall be arranged by the Agency and same shall conform to relevant specification/I.S. code.
3. Payment shall be made as per actual measurement at site of work.
4. The date of start shall reckoned from next date of issue of work order.
5. Time is essence of the contract and work shall be carried out in time bound manner.
6. No T & P shall be issued.
7. No extra charges shall be paid except for the rates quoted.
8. Conditional quotations shall be liable to rejection.
9. For any disputes the matter shall be referred to SE-III DUSIB for final decision and the same shall be binding upon both the parties.
10. Earnest Money of other than Ist lowest quotationers will be released after opening of quotations and earnest money amount of Ist lowest bidder will be adjusted in security deposit (to be deducted) from payments of bill.
11. 10% Security shall be deducted from the bills of contractor which shall be refunded after three month of completion of work.
12. Necessary statutory deductions will be made as per prevailing Law.
13. Work shall be completed to the satisfaction of Engineer-in-charge.
14. Debarred/blacklisted agencies shall not be permitted to participate in the NIQ process.
