### ADDITIONAL TERMS & CONDITION FOR PUMP ISTALLATION WORK

- 1. All the material shall have to be got approved from Engineer-in-charge.
- 2. The work is to carried out in the presence of site in-charge.
- 3. The quoted rates shall be inclusive of freight, transit, insurance, loading, unloading charges, octroi, GST etc.
- 4. The agency shall submit the manufactures. Test certificates, Guarantee/warrantee cards and manuals in original.
- 5. The delivery of the material is to be given at site of work.
- 6. The agency shall arrange to depute qualified company trained person(s) at the time of installation of pump set(s).
- 7. The agency shall arrange for the demo-testing of the pump set(s) at site as and when required.
- 8. No T&P shall be issued departmentally.
- 9. Functional Defects/complaints during the guarantee/warranty period shall be rectified by the contractor.
- 10. Nothing extra shall be paid on all above accounts.
