Sealed Item Rate quotations are hereby invited from agencies dealing with for providing service facility with portable toilets cubicles as a solution provider with technology at the liberty of the quotationer agency for locations where no sewage disposal and water is available and have successfully executed similar works or in hand for the under mentioned work, the companies/firms /agencies should be registered under any statutory act enacted by Govt. of India.

The quotationer shall submit the following documents along with application in the office of the Executive Engineer (E-2).

Note: DUSIB expects the Bids only from those agencies who apart from providing portable toilet cubicles and have the capacity to arrange water as well as sewage disposal from these cubicles sites to the nearest point of disposal in a legalized permissible manner following all the lid down guidelines of CPCB, CSE, NGT for local department dealing with sewage system.

- iii) Photo copy of the company/Firm/Agency registered under any statutory Act enacted by Govt. of India.

- v) Photocopy of Document showing the Bidder Company or its domestic/International Principal/Parent/Group Company dealing with undertaking similar facility of works in India or elsewhere.

**TERMS & CONDITIONS:**

1. The work should be completed within **3 Months** after the date of receipt of the work order.
2. No extra charges shall be paid.
3. Conditional quotations shall not be accepted and will be summarily rejected. The materials should be only as per specifications, duly approved by site in charge, before use.
4. T&P shall be borne by the agency.
5. For any type of accident, mishaps during execution of work at site shall be sole responsibility of the agency and department shall not be in any case be responsible and liable for such type of accident or mishap.
6. Damage to the building shall be made good by the agency at his own cost.
7. Quotation received after the due date and time will not be considered.
8. Payment shall be made by RTGS.
9. The EE(E-2) has the right to reject or accept the quotation.
10. All disputes shall be within the jurisdiction of Delhi.
11. Substandard work shall be liable in not release of payment for that article and the agency will be blacklisted, debarred for misleading the department.
12. The firms shall have to submit the copy of registration certificates which shall be valid on the date of receipt of application.
13. Quotation in sealed cover in prescribed NIQ format issued by the office shall only be accepted. Any quotation other than the prescribed NIQ format shall not be entertained.
14. Statutory deductions i.e 2% Income tax, 1% Labour Cess and GST as applicable will be made from each bill of the contractor.
15. The service provider agency shall be fully responsible for safety of labour working staff and any one deployed at the facility. Proper safety equipment as per requirement for site shall be provided by the agency and agency shall be fully responsible for any accident and consequential claim etc. & DUSIB shall not be responsible in any manner.
16. The agency shall be clearing and suctioning waste & water tanks on regular basis as and when required.
17. The agency shall keep the facility in a clean, tidy and orderly condition free of litter dirt and debris.

18. The agency shall be responsible for maintenance of the drainages within individual toilet in accordance with Good Industry Practices.
19. The water consumption charges (if any) & Electricity charges shall be borne/paid by the service provider agency. The agency can provide solar lighting system in the service facility area.
20. the agency shall ensure proper check at the entrance so that male users not attempt to enter the women section. The agency shall ensure utmost privacy and safety of the women users. The agency shall install all the cubicles in such a way to ensure privacy and safety women users.
21. During random checks by any representative, of DUSIB or Engineer-in-charge if any W.C. or its immediate surrounding is found to be unhygienic or dirty, an compensation of Rs. 100 per event shall be levied against the agency per default.
22. If chocking/blockage or overflowing of internal sewerage is observed, a compensation of Rs. 200 per event shall be levied.
