Estimated Cost :- 7,40,886.00
Time Allowed :- 45 Days

The quotation along with copy of registration, PAN Card, GST registration should reach to the office of the Executive Engineer C-5 (DUSIB) latest by 3.00 P.M. on 25.04.2018 which shall be opened on 25.04.2018 at 3.30 P.M. in the presence of intending quotationers or their representatives. The intending quotationers may collect the schedule of quantities (along with terms and conditions) from the office of the undersigned.

Terms & Conditions:-

- 1 The work shall be carried out as per CPWD specifications.
- 2 Payment shall be made as per actual measurement at site of work.
- 3 No T&P shall be issued.
- 4 No extra charges shall be paid except for the rates quoted.
- 5 No manual scavenging shall be allowed and agency shall take all precaution for safeguard of the labour deployed at site.
- 6 Conditional quotations shall be liable to rejection.
- 7 For any disputes the matter shall be referred to CE-I DUSIB for final decision and the same shall be binding upon both the parties.
- 8 Necessary Statutory deductions will be made as per prevailing law.
- 9 Work shall be completed to the satisfaction of Engineer-in-charge.
- 10 Debarred / blacklisted agencies shall not be permitted to participate in the NIQ process.
- 11 The work shall be completed within 45 days after award of work
- 12 Taxes as applicable as on date shall be deducted from the bills of Contractor. Security shall be deducted @ 10% of each bill and same shall be refunded after six months of completion of work.
