The terms & Conditions of the spot quotation are as follows:-

1. The work shall be carried out as per CPWD specifications.
2. Payment shall be made as per actual measurement at site of work.
3. No T & P shall be issued.
4. No extra charges shall be paid except for the rate quoted.
5. Conditional quotations shall be liable to rejection.
6. For any disputes the matter shall be referred to CE-I DUSIB for final decision and the same shall be binding upon both the parties.
7. Statuary recoveries shall be deducted from the bills of contractor as per rules.
8. Work shall be completed to the satisfaction of Engineer-in-charge.
9. Debarred/blacklisted agencies shall not be permitted to participate in the NIQ process.
10. Taxes as applicable as on date shall be deducted from the bill of Contractor, Security shall be deducted @ 10% of each bill and same shall be refunded after six months of the completion of work.




