

2. Submission of four copies of detailed ~~Soil investigation~~ ^{Soil investigation} as per item.
3. Payment shall be made as per actual measurement at site of work and payment will be made after acceptance of report by Competent Authority/Engineer-in-charge.
4. No T& P shall be issued by the Department.
5. No extra charges shall be paid except for the rates quoted.
6. Conditional quotations shall be liable to rejection.
7. For any disputes the matter shall be referred to SE-4/ DUSIB for final decision and the same shall be binding upon both the parties.
