The firms who wish to participate in quotation shall submit their application for issue of prescribed schedule of quantities up to 09.07.2019 12.00 P.M. along with the following documents, failing which their application is liable to be rejected.

1. Copy of their registration certificate.
2. Copy of pan card.
3. Registration under GST.

The scheduled of quantities of the quotations can be obtained from this office on 09.07.2019 upto 12.00 P/M. The intending quotationer, collect the terms and conditions and other information from the office of Ex. Engineer/C08, DUSIB.

The quotations should reach to the office of the Executive Engineer, C-8, DUSIB latest by 3.00 PM on 10.07.2019 which shall be opened on the same day at 3.30 PM in the presence of intending quotationers or their representatives.

1. The work shall be carried out as per CPWD specifications 2016 Vol. I & II /latest editions of the specifications, with up to date (the date of receipt of tender) correction slips, for works at Delhi.
2. Cement/steel required shall be arranged by the Agency and same shall conform to relevant specification/I.S. Code.
3. Payment shall be made as per actual measurement at site of work.
4. No T& P shall be issued.
5. No extra charges shall be paid except for the rates quoted.
6. Conditional quotations shall be liable to rejection.
7. For any disputes the matter shall be referred to SE-III DUSIB for final decision and the same shall be binding upon both the parties.
8. 10% Security shall be deducted from the bills of contractor which shall be refunded after three month of completion of work.
9. Necessary statutory deductions will be made as per prevailing Law.
10. Work shall be completed to the satisfaction of Engineer-in-charge.
11. Debarred/blacklisted agencies shall not be permitted to participate in the NIQ process.
