

The intending quotationers may collect the schedule of quantities and other information from the office of the undersigned by 3:00 PM on 27.07.2019. The terms and conditions of the NIQ are as follows:-

1. The work shall be carried out as per terms and conditions of CPWD specifications with up to date correction. Conditional quotations shall be liable for rejection.
2. For any disputes the matter shall be referred to Chief Engineer-I for final decision and same shall be binding upon both the parties.
3. Necessary statutory deductions will be made as per prevailing tax rates.
4. Works shall be completed as per satisfaction of Engineer-in-charge.
5. Debarred/blacklisted agencies shall not be permitted to participate in the NIQ process.
6. Copy of GST No. And Pan Card shall be provided along with the quotation by the bidder.
7. Schedule of quantity may also be downloaded from the DUSIB site.
8. Completed three no. Of similar nature of works of atleast 80% of cost be attached along with the quotation. This will be the deciding factor for the acceptance of the quotation.
9. Quoted Rates are inclusive of all the applicable taxes.
10. Design must be vetted from reputed institute such as I.I.T., D.T.U. or Jamia.
11. Participating Firm/Company must have qualified /Expert in Structural Engineering.
12. Backup calculation will also be submitted with vetted design in soft copy.
