General conditions for Electrical work

- 1. The work shall be carried out strictly in accordance with CPWD specifications of Electrical works 2013 as amended upto date and in accordance with Indian Electricity Rules 1956, Indian electricity Act, 1910 as amended upto date.
- 2. The work shall be carried out according to approved drawing and as per instructions of the Engineer in charge (Electrical) who will have the right to change the layout as per requirement at site and the contractor shall not have any claim due to change in layout.
- 3. All damage done to the building during execution of Electrical work shall be the responsibility of the contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-charge (Electrical). Any expenditure incurred by the department in these conditions shall be recovered from the contractor and decision of the Engineer in charge (Electrical) about recovery shall be final.
- 4. All the debris of the electrical works should be removed and the site should be cleared by the contractor immediately after the removing of debris. Similarly any rejected material should be immediately cleared off from the site by the contractor.
- 5. Issue of material to the contractor wherever stipulated, shall be according to the requirement at site from time to time depending upon the progress of work.
