TERMS & CONDITIONS:

1. The work should be completed within 04 days after the date of receipt of the quotation order.
2. The agency shall deploy tempos along with driver and helpers at 10.00 AM at site. As per direction of EE/E-4.
3. In case the tempos stationed from 10.00 AM to 2.00 PM and no shifting takes place than the payment for one trip shall be given only.
4. In case the tempos are stationed 10.00 AM onwards for whole day and single trip of shifting take place, in this situation the payment of 02 trip shall be given.
5. No extra payment shall be made for Driver, Helper, Fuel, Toll Tax, Challan of local police if any.
6. No extra charges shall be paid.
7. Conditional quotations shall not be accepted and will be summarily rejected.
8. The materials should be only as per specifications, duly approved by site in charge, before use.
9. T&P shall be borne by the agency.
10. Drinking water arrangement shall be made by agency for labour working at site at his own cost.
11. For any type of accident, mishaps during execution of work at site shall be sole responsibility of the agency and department shall not be in any case be responsible and liable for such type of accident or mishap.
12. Quotation received after the due date and time shall be liable for rejection & in no case shall be entertained.
13. No out of station quotation shall be entertained and accepted.
14. The E.E(E-4) has the sole right to reject or accept the quotation.
15. All the scraps and surplus material shall be removed from the site.
16. All the rejected, un approved material should be removed from the site, the site should be made clear.
17. Substandard work shall be liable in not release of payment for that article and the agency will be blacklisted, debarred for misleading the department.
18. The Watch & Ward, storage of the material shall be the responsibility of the work executing agency, till handed over to DUSIB.
19. The firms shall have to submit the attested copy of above certificates for verification original certificate be also produced which shall be valid on the date of receipt of application.
20. Quotation in sealed cover for items only prescribed NIQ format issued by the office shall only be accepted. Any quotation other than the prescribed NIQ format issued by this office shall not be entertained.
21. The deduction of [Security@2.5%](#), Income Tax, & Labour cess shall be deducted from the gross amount of the bill as per rules.
22. If any component, in addition to mentioned scope of work is required for meeting prescribed effluent parameters, the contractor shall provide same without claiming any extra payment.
23. The Earnest Money deposited shall be returned except L-1 after issue of work order.
