1. The work shall be carried out as per CPWD specifications 2014 Vol-I & II with upto date correction slips as per direction of Engineer -in- charge.
2. Payment shall be made as per actual measurement at site of work and payment will be made after acceptance of report by Competent Authority/ Engineer-in-charge.
3. No T& P shall be issued by the Department.
4. No extra charges shall be paid except for the rate quoted.
5. Conditional quotations shall be liable to rejection.
6. For any disputes the matter shall be referred to CE-I DUSIB for final decision and the same shall be binding upon both the parties.
7. Necessary statutory deduction will be made as per prevailing Law.
8. Work shall be completed to the satisfaction of Engineer-in-charge.
9. Debarred/blacklisted agencies shall not be permitted to participate in the NIQ process.
10. The Earnest money amounting to Rs. 1000/- (Rupees One Thousand only) @ 2% of estimated cost of work in the shape of Pay order/Demand Draft in favour of EE C-3 Dusib is required to be enclosed on the top of NIQ envelop.
11. NIQ shall be submitted in sealed envelope along with the quoted rates and necessary documents.
