

(C-06), AE concerned, AAO(C-06) and intending quotationers or their representatives. The intending quotationers may collect the schedule of quantities and other information from the office of the Executive Engineer (C-06), DUSIB. The terms and conditions of the NIQ are as follows:

TERMS & CONDITIONS :

1. The work shall be carried out as per CPWD specifications 2014 Vol. – I & II with upto date correction slips as per direction of Engineer-in-Charge.
2. Payment shall be made as per actual measurement at site of work and payment will be made after acceptance of report of Competent Authority/Engineer-in-Charge.
3. No T&P shall be issued by the Department.
4. No extra charges shall be paid except for the rate quoted.
5. Conditional quotations shall be liable to rejection.
6. For any disputes the matter shall be referred to Chief Engineer – I, DUSIB, for final decision and the same shall be binding upon both the parties.
7. Necessary statutory deduction will be made as per prevailing law.
8. Work shall be completed to the satisfaction of Engineer-in-charge.
9. Debarred/blacklisted agencies shall not be permitted to participate in the NIQ process.
10. The Earnest Money amount to Rs.45,300/- (Rupees Fourty Five Thousand Only) @ 5% of the estimated cost of work in the shape of Pay Order/Demand Draft in favour of E.E. C6, DUSIB put to NIQ along with necessary documents will be submitted.
11. Taxes as applicable as on date shall be deducted from the bill of Contractor, Security shall be deducted @ 10% of each bill and same shall be refunded after three months of the completion of work
