Six copies of the structural design, calculations along with six blue print(06 Nos) of structural drawings showing all salient features i.e. Technical details, sections of various members of such as footing, beams, columns, slabs, lintels etc. Shall be submitted by the designer as per relevant IS Codes, Currently in practice and earthquake resistance for approval from the competent authority within 15 days of issue of award letter.
- 3. The original tracing of the drawing shall be the property of DUSIB i/c soft copy of all drawings.
- 4. The payment shall be made only submitting structural design and all drawings.
- 5. No T&P shall be issued by the department.
- 6. Deduction of statutory taxes shall be made by the department from the bill of the agency at the usual rates.
- 7. The design should be economical, safe and structural stability of the structures be certified by the designer.
- 8. The agency will get the requite design vetted from premier institute like D.T.U, IIT, Jamia Millia Islamia etc any modification suggested by vetted agency will be incorporated by the agency.
