Sealed quotations are hereby invited from approved and eligible Electrical contractors registered of CPWD, Railways, MES and Civil wing of BSNL, MCD, DDA, NDMC, Delhi Jal Board, I&F Deptt., Delhi, Delhi State PWD Agencies/contractors registered with central / state Govt. Departments, corporations, undertakings, Development Authorities on behalf of DUSIB for the under mentioned work.

The agency shall submit the following documents along with application in the office of the Executive Engineer (E-2).

- i). Copy of GST registration number.
- ii). Copy of Valid registration certificate of the department registered with (In case of registered contractors.
- iii). Copy of PAN card issued by income tax department.
- iv). Copy of Valid Electrical Contractor License.
- v). Earnest money of Rs. 1100/- in shape of demand draft in favour of EE/E-2 DUSIB. Should be accompanied with the application for participating in the quotation EM will be return to unsuccessful bidder at the time of opening of bid and after successful completion of the work to the successful bidder.

The quotation should reach this office on today i.e **02-07-2020** by 02.00 PM which shall be opened on the same day at 2:30 PM in the presence of the participating contractors or their representatives to be present at the time of opening of NIQ.

The firms to participate in the quotation shall submit their application, along with the above documents for issue of prescribed NIQ format on or before **02-07-2020** by 01:00 PM. The prescribed NIQ format, detail description of the item, detailed specifications of the quotations can be obtained from this office on or before **02-07-2020** up to 01:00 PM.

General conditions for Electrical work

1. The work shall be carried out strictly in accordance with CPWD specifications of Electrical works as amended upto date and in accordance with Indian Electricity Rules 1956, Indian electricity Act, 1910 as amended upto date.
2. The work shall be carried out according to as per instructions of the Engineer in charge (Electrical) as per requirement at site.
3. All damage done to the building during execution of Electrical work shall be the responsibility of the contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-charge (Electrical). Any expenditure incurred by the department in these conditions shall be recovered from the contractor and decision of the Engineer in charge (Electrical) about recovery shall be final.
4. All the debris of the electrical works should be removed and the site should be cleared by the contractor immediately after the removing of debris. Similarly any rejected material should be immediately cleared off from the site by the contractor.
5. Issue of material to the contractor wherever stipulated, shall be according to the requirement at site from time to time depending upon the progress of work.
6. Cement sand etc for this work is to be arranged by the contractor himself and nothing extra will be paid on this account.
7. The contractor shall make his own arrangement at his own cost for electrical general tools and plants required for the work including arrangement of water and electricity.
8. The entire installation shall be at the risk and responsibility of the contractor until these are tested and handed over to the department.
9. The connection, inter connection, shall be done by the contractor wherever required and nothing extra shall be paid on this account.
10. Nothing extra shall be paid for inter connections with thimbles / wires / tapes strips etc.
11. PVC insulated copper conductor wire used on the work shall be FRLS grade for which nothing extra shall be paid.
12. The make of material have been indicated in the list of acceptable makes. No other make will be acceptable. The material to be used in the work shall be got approved from the Engineer in charge before its use at site. The Engineer in charge (Electrical) shall reserve the right to instruct the contractor to remove the material which, in his opinion, is not as per specifications.


General conditions

1. The work should be completed within **05 Days** after the date of receipt of the work order
2. No extra charges shall be paid.
3. Conditional quotations shall not be accepted and will be summarily rejected. The materials should be only as per specifications, duly approved by site in charge, before use.
4. T&P shall be borne by the agency.
5. For any type of accident, mishaps during execution of work at site shall be sole responsibility of the agency and department shall not be in any case be responsible and liable for such type of accident or mishap.
6. Damage to the building shall be made good by the agency at his own cost.
7. Quotation received after the due date and time will not be considered.
8. Payment shall be made by RTGS.
9. The EE(E-2) has the right to reject or accept the quotation.
10. All disputes shall be within the jurisdiction of Delhi.
11. Substandard work shall be liable in not release of payment for that article and the agency will be blacklisted, debarred for misleading the department.
12. Quotation in sealed cover in prescribed NIQ format issued by the office shall only be accepted. Any quotation other than the prescribed NIQ format shall not be entertained.
13. Security shall be deducted from the bill @ 10% of the total value of work done.
14. Statutory deductions shall be deducted on the prevailing Govt. rates.
