The intending quotationers may collect the schedule of quantities (along with terms and conditions) from the office of the undersigned.

Terms & Conditions:-

1. The work shall be carried out as per CPWD specifications.
2. Payment shall be made as per actual measurement at site of work.
3. No T&P shall be issued.
4. No extra charges shall be paid except for the rates quoted.
5. Conditional quotations shall be liable to rejection.
6. For any disputes the matter shall be referred to SE-II DUSIB for final decision and the same shall be binding upon both the parties.
7. Security deposit will be deducted @ 5% of bill of the contractor and shall be refunded after three months of completion of the work.
8. Necessary Statutory deductions will be made as per prevailing law.
9. Work shall be completed to the satisfaction of Engineer-in-charge.
10. Debarred / blacklisted agencies shall not be permitted to participate in the NIQ process.
11. The work shall be completed within 15 days after award of work
12. 2% Income Tax, 1% Labour Cess, 1% CGST, 1% SGST shall be deducted from the bills of Contractor.
