The prescribed NIQ format, detail description of the item, detailed specifications of the quotations can be obtained from this office on or before 11.04.2022 upto 2.30 PM.

- Drinking water arrangement shall be made by agency for labour working at site at his own cost.
- For any type of accident, mishaps during execution of work at site shall be sole responsibility of the agency and department shall not be in any case be responsible and liable for such type of accident or mishap.
- Quotation received after the due date and time will not be considered.
- Payment shall be made by RTGS.

- 13. All the scraps and surplus material shall be removed from the site.
- 14. All the rejected, un approved material should be removed from the site.
- 15. Sub standard work shall be liable in not release of payment for that article and the agency will be blacklisted, debarred for misleading the department.
- The Watch & Ward, storage of the material shall be the responsibility of the work executing agency.
- 17. The firms shall have to submit the attested copy of above certificates which shall be valid on the date of receipt of application.
- 18. Quotation in sealed cover for items only prescribed NIQ format issued by the office shall only be accepted. Any quotation other than the prescribed NIQ format issued by this office shall not be entertained.
- 19. If any component, in addition to mentioned scope of work is required for meeting prescribed effluent parameters, the contractor shall provide same without claiming any extra payment.
- 20. Intending bidders are advised to see the site conditions before quoting the rates.
- 21. Statutory deductions shall be deducted on the prevailing Govt. rates.
- Work shall be carried out strictly as per CPWD specifications.
