However, the blacklisted and/or those contractors who have been debarred from future tendering in any Department shall not be eligible. The intending quotationer may collect the schedule of quantities, terms and conditions and other information from the office of the Executive Engineer, C-8/DUSIB.

The contractor who wishes to participate in quotation for above work shall submit their quotation by 23.06.2022 upto 3.00 PM alongwith the following documents at the office of the Executive Engineer (C-08) and the same shall be opened at same place at 4.00 PM:

- 1) Copy of Registration Certificate of the Firm.
- 2) Copy of PAN Card
- 3) Copy of GST Registration.
- 4) Demand Draft in favour of Executive Engineer (C-08) amounting to Rs.18,000/-.

TERMS & CONDITIONS:

- 1. The work shall be carried out as per CPWD specifications 2016 Vol. I & II/latest editions of the specifications, with up to date (the date of receipt of tender) correction slips, for works at Delhi.
- 2. Payment shall be made as per actual measurement at site of work and payment will be made after acceptance of report of Competent Authority/ Engineer-in-Charge.
- 3. Conditional quotation shall be liable to rejection.
- Cement/Steel required shall be arranged by the Agency and same shall confirm to relevant specifications/I.S. Code.
- Time allowed for completion of work shall be 15 DAYS which shall be reckoned from the date after the date of approval from Competent Authority.
- 6. No T&P shall be issued by the Department.
- 7. No extra charges shall be paid except for the rate quoted.
- 8. For any disputes the matter shall be referred to Chief Engineer II, DUSIB, for final decision and the same shall be binding upon both the parties.
- 9. Necessary statutory deduction will be made as per prevailing law.
- Work shall be completed to the satisfaction of Engineer-in-Charge.
- 11. Taxes as applicable as on date shall be deducted from the bill of Contractor, Security shall be deducted @ 10% of each bill and same shall be refunded after three months of the completion of work.
- 12. The Contractor is required to comply with labour rules w.r.t. leave medical and minimum wages etc.
