4. Necessary statutory deductions will be made as per prevailing law.
5. Works shall be completed as per satisfaction of Engineer-in-charge.
6. Debarred/blacklisted agencies shall not be permitted to participate in the NIQ process.
7. Copy of Earnest Money, Registration Certificate, ESI, PF, GST No., Pan Card shall be submitted with the quotation by bidder.


